### **Review Current Plan/Budget for 2022-23 School Year**

Principal Roden presented the 2022/2023 School Plan to the council members. Additional teaching periods will lower class size and allow teachers to provide more targeted instruction and increase learning. An SEE student will be hired to help support 6<sup>th</sup> Grade Language Arts reach literacy goals.

### **School Mission, Vision and Goals for 22-23 School Year**

Mrs. Roden presented the Mission Goals; to improve literacy in all content areas, increase student reading scores and increase academic achievement.

### **Data review of 21-22 School Year: Proficiency and Growth**

Principal Roden presented charts which showed Tonaquint levels stayed at level or grew within the 21/22 school year.

**Digital Citizenship Presentation:** Assistant Principal Lacy Olmstead discussed several programs to provide internet safety. The students have two orientation days each year to go over safety and policies. The teachers use a program called Impero which gives them access to see what sites are being accessed by students while using chrome books in the class room.

**Safe Routes Presentation:** Mrs. Olmstead and SRO Adams discussed safe routes. Five to eight percent of students walk to school using sidewalks and crosswalks. In boundary parents whose children walk, can apply for "space available" through the Transportation Department.
